

Personal Financial Planning

This course introduces mini-MBA students to concepts, tools and strategies that enhance personal financial security. We analyze retirement needs and discuss qualified and non-qualified retirement plans and employee benefits. We also analyze topics in estate planning, including wills, trusts, and powers of attorney. Finally, we provide an overview of personal risk management topics, including property, casualty, liability and disability insurance.
