## FEI HOUSTON – TED BAUER UNDERGRADUATE BUSINESS SCHOLARSHIP APPLICATION

### SCHOLAR INFORMATION APPLICATION:

Financial Executives International (FEI) Houston annually awards an FEI Houston– Ted Bauer Undergraduate Business Scholarship funded by the C.T. Bauer Foundation. This scholarship is for a full-time undergraduate business student in the fields of Accounting or Finance enrolled in the C.T. Bauer College of Business at the University of Houston. The award is for \$14,000 for one year, and renewable for a second year if all conditions are met with an additional \$14,000, for a total award of \$28,000. It is intended to assist the student to complete the remaining two years of their B.B.A.

### NOMINEE ELIGIBILITY:

- Must have four full-time (minimum 12 hours/semester) semesters remaining starting Fall 2022, with a graduation date of May 2024.
- Enrolled in the C.T. Bauer College of Business as a Pre-business major intending to major in either Accounting or Finance, or a declared major in Accounting or Finance.
- Minimum Grade Point Average of 3.5/4.0 in their Major course of study, and a minimum Grade Point Average of 3.5/4.0 Overall.
- Active participant in campus and community service work.
- Deserving student without significant other scholarships, demonstrating financial need.
- Submission of a well-written, meaningful essay regarding interest in Accounting / Finance
- Citizen of the U.S.A. or Permanent Resident.
- Graduation date May 2024.

### OTHER REQUIREMENTS:

- The C.T. Bauer College of Business will receive this application form for review and approval by the Dean of the Bauer College of Business and the Ted Bauer Undergraduate Business Scholarship Committee as meeting the requirements and verifying financial need, and then if selected, will forward the application to FEI Houston for final review and selection.
- Attendance at the Academic Honors Day (AHD) full-day and evening event on **February 15, 2022** in Houston is a prerequisite to receiving the award.
- Student has not previously received an FEI Houston Scholarship Foundation award.

**To be considered for nomination for this year's FEI Houston – Ted Bauer Undergraduate Business Scholarship from FEI Houston Scholarship Foundation, candidate's application must be approved by the Dean of the C.T. Bauer College of Business, and the Ted Bauer Undergraduate Business Scholarship Committee.
