Course Description

The objective of this course is to give an overview of capital markets and different securities. We discuss equity, fixed income securities, and derivative securities. We provide an overview of the institutional environment: which products are available and how are they traded? We also analyze pricing models and the regulatory environment.

Textbook

Required: Bodie, Kane, and Marcus, **Investments**, McGraw-Hill Irwin, Twelfth Edition, ISBN 978-1-260-81938-0. There is a solution manual for the end-of chapter exercises. I don't mind you using it in a responsible way.
