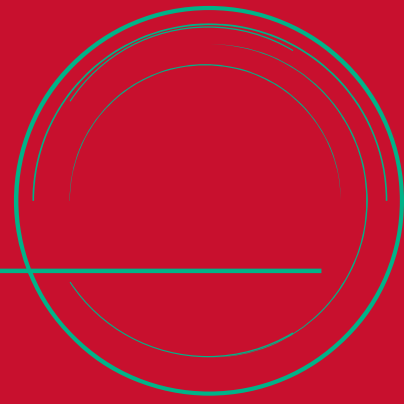

FINANCIAL AID

- > Financial aid is available to U.S. citizens and permanent residents through the federal government.
- > An application is available through the Free Application for Federal Student Aid website, at www.studentaid.gov. Complete your FAFSA as soon as possible after October 1 of the year you plan on attending.
- > International Students should contact International Student & Scholar Services for information on financial aid services which include scholarships, emergency aid and more.

GRANTS

- > Grants are available on a limited basis for Bauer graduate students.

SCHOLARSHIP

- > Prospective students who meet certain requirements may be eligible for scholarships available through the university, college, or department.
- > Scholarships are available for both domestic and international students.
- > Eligibility requirements vary based upon scholarship criteria.
- > Some scholarships come with an in-state tuition waiver (if needed).
