General Information:

This is an introductory course providing an overview of commercial real estate capital markets analysis and financing. This course will focus on basic fundamentals, key terms, financial tools, financial analysis, basic strategy and decision making related to commercial real estate. The teaching method we shall use shall be a combination of class participation and discussion/analysis of daily events, learning and using key definitions and calculations, and basic financial calculations.

Course Objectives:

Once students successfully complete this course they will have a good understanding of commercial real estate capital markets and be able to follow and discuss real estate finance as well as the key terms & calculations, strategies and methods commonly used and why.

Required Skills:

Students taking this course are expected to know how to use a financial calculator and its functions (such as HP 12c or TI BA II) plus Excel. All students shall need a financial calculator in class. Working knowledge of Time Value of Money and related calculations.

Text:

Attendance and Participation:
