### Internship Program - Overview and Registration Summer 2019

#### **Overview**

The internship program provides students in the Real Estate Program with professional work experience and provides an introduction to employers that will support a practice-based education. Student interns need to be enrolled in the Professional Internship for-credit course. The internship course instructor will provide coordination and counseling.

#### Terms of Internship Employment

- Internships only available to students who are registered with the Real Estate Program, have completed at least one career counseling session, and who will have received a passing grade in at least one real estate course prior to the internship.
- Availability for internship employment
  - 40 hours per week or otherwise as agreed by employer and intern
  - o Monday, June 3 through Friday, August 9
- Compensation will be set by your employer and ranges between \$10-\$15/hour for undergraduate students and \$15-\$20/hour for graduate students.
- Interns are employed according to the employer's HR policies and procedures.



- Interns are assigned a supervisor.
- Employer sets work assignments that offer educational benefits, adds value to employer's programs with set objectives to achieve by the end of the internship.
- Employer appraises the intern's performance at the conclusion of the course and submits it to the instructor.

#### **Internship Candidates and Registration**

- MBA, MS Finance, and BBA Finance students in the Real Estate Program are eligible to participate in the internship program.
- The student must be available for full-time or part-time employment in summer 2019.
- The student must complete an internship registration form and provide a current resume to the Real Estate Program office by <u>November 30, 2018</u>.

#### **Internship Course**

• Students must enroll in the internship course available in summer 2019.

#### Matching Process

- The Real Estate Program staff will match students and employers.
- Employers and students also have the opportunity to choose each other through a facilitated process.
