### **COURSE DESCRIPTION**

This three-credit undergraduate course focuses on introductory financial theories and their real-world financial applications that are useful in investment decision-making process.

Students will acquire a solid grasp of modern investment theory and practice. This will include the understanding of the following:

- The institutional environment i.e., type of products traded and the trading mechanism.
- The trade-off between risk and return in a portfolio consisting of several assets.
- The pricing of each product: equity and debt securities

The hallmark of modern portfolio theory is a mathematical and statistical approach to these questions. This approach is used by most investment banks, hedge funds and portfolio managers. Part of this course and the exams will therefore be quantitative in nature.

This course is divided into three parts:

Part I - *Elements of Investments* 

Part II – *Portfolio Theory* 

Part III – Debt Securities

### **COURSE EVALUATION**

The course evaluation is based on the criteria mentioned below, with a maximum possible score of 105 points:

**Midterm Exams (40 points):** Two midterm exams, 20 points for each. Midterm 1 will be held on September 24<sup>th</sup> and midterm 2 on October 31<sup>st</sup>.

**Final Exam (30 points):** The final exam will be held on December 10<sup>th</sup>.

All exams will be closed-book and in-class. The material to be covered in each exam will be announced in class.

If you score higher in a later exam, that score will replace the earlier exam's scores. For example, if you score higher in midterm 2 than in midterm 1, the midterm 2 score will replace the midterm 1 score. If you score higher in the final exam than in either/both of the midterms, the final exam score will replace either/both of the midterm exam scores.

**Assignments and Excel Exercise (25 points):** Three assignments for 5 points each and an excel exercise for 10 points. The assignments are due on September 17<sup>th</sup>, October 24<sup>th</sup> and November 19<sup>th</sup>. The excel exercise is due on November 17<sup>th</sup>. *Late submissions will not be accepted.* 

**Quizzes** (5 points): There will be up to six in-class quizzes. Each quiz will consist entirely of multiple choice questions. I will consider your best three quiz scores across all the quizzes. The dates and the material for the quizzes will be announced in class.

Class Attendance and Participation (5 points): Students are encouraged to ask questions and initiate insightful discussions among fellow classmates. Participation is extremely important; merely attending every class does not guarantee full points.
